# **Sunshine Meeting briefing**

# **Pluris-Wedgefield Project**

Tuesday, July 18 from 3:30 pm to 5:30 pm

**Summary** 

### **Overview**

The purpose of this meeting is to thoroughly discuss the Pluris-Wedgefield project. The Commissioners will receive updates on the progress made in the Wedgefield community and the collaborative efforts between Commissioner Bonilla's office and OCU to advance the project. The scope and rationale for presenting the project to the Board will also be covered. Additionally, the feedback from Wedgefield residents will be reviewed and discussed. To ensure transparency and community involvement, Wedgefield residents will be invited to attend the Sunshine meeting. The invites for this meeting were sent to the Commissioners, OCU, and Wedgefield residents.

# **Objective**

Commissioner Bonilla aims to equip the Commissioners with a comprehensive understanding of the issue and the current progress in the Wedgefield community. This information will be instrumental in enabling them to make an informed decision during the upcoming BCC Meeting on July 25th.

## Background/Research

- Demographics: Wedgefield, Florida, is located in Southeast Orange County. According to the 2010 census, it has a population of approximately 6,705 people with a median age of 36.4 and a median household income of \$76,000, and per capita income of \$31,695. The median property value in Wedgefield, FL, is \$242,200, and the homeownership rate is 87.9%.
- Background: Since its inception in 1962, Wedgefield's water and wastewater services have been privately owned. In 1996, Wedgefield Utilities, Inc. sold to Pluris Holdings, LLC, and in 2009 Pluris Holdings, LLC sold to the current owners, Pluris. Over the years, Orange Page 1 of 3

County has received complaints from Wedgefield residents as follows: water quality, water aesthetics, high rates/pricing, and lack of responsive customer service. Pluris was involved in a lawsuit, settled in April 2023. Since late 2016, when I took office, I have continued Orange County's effort to resolve this issue.

- Issue: Of most importance, the results of our 2018 consulting report shows that Pluris charges rates over 154% higher than OCU rates. Pluris is regulated by the Florida Public Service Commission (PSC). PSC's approved return on equity is 8.3%. The rate of return is noteworthy because when Pluris responds to customer complaints, any subsequent improvement results in a cost increase over and above to allow Pluris to keep its 8.3% rate of return. The unfortunate result is that prices continue to climb, and the Wedgefield constituents are stuck with paying excessive amounts for their water and wastewater services. The most recent price increase was June 9, 2023, two months after their recent lawsuit was settled.

- Issue #2: a direct connection to OCU infrastructure is not viable due to water quality concerns associated with long piping (approximately 6 miles of piping) and the resulting water age. Furthermore, in addition to costs for acquisition and upgrade of the Wedgefield water system, the approximate costs associated with piping extensions would be \$20,000,000 plus capital charges. Therefore, purchase and maintenance of the current system is the only viable economic option to relieve the Wedgefield constituents of the overburdened cost (which continues to rise) of their water utilities.

- Two community meeting were held with the residents of Wedgefield to update the residents on the on the County's communications with Pluris and to discuss a proposed straw poll with the residents.

The purpose of this letter is to provide you and the nearly 1,800 other Wedgefield property owners with the opportunity to participate in a straw poll to determine your interest in purchasing the Pluris-Wedgefield Water & Wastewater System (System). Property owners will be required to contribute 100% of the purchase of the System in the form of a fixed amount as outlined below.

Property owners also need to express their desire for Orange County to set up the owner purchase as a Municipal Service Benefit Unit (MSBU). An MSBU designation would spread out the cost over a 20-year period. This fixed amount assessment would be included on the annual property tax bill for all 1,800 properties.

Your feedback is especially important as it will determine if this project advances. To do so, at least 67% of property owners are required to answer "in favor" of the purchase. Property owners who don't complete and return the straw poll ballot in the allotted time frame will be counted as having answered "not in favor" of the purchase. Please limit ballot responses to one property owner per parcel to ensure we receive an accurate gauge of your collective interest in purchasing the System. The responses will be included in an update to the Orange County Board of County Commissioners sometime this summer.

Please complete the attached straw poll ballot and return it by mail using the prepaid postage envelope. For your vote to be counted, it must be postmarked by June 17, 2023. 


# RETURN YOUR STRAW POLL BALLOT!

Residents of Wedgefield have raised concerns regarding the utility services provided by Pluris Wedgefield, LLC. These concerns include the quality and appearance of the water, high rates, and poor customer service. Pluris was involved in a lawsuit regarding the quality of their water. As of April 2023, they have been ordered to pay \$3.3 million to settle the case. Currently, Pluris Wedgefield, LLC charges rates that are more than 98% higher than those of OCU, and Pluris recently announced their plans for a rate increase in the coming months. Presently, Pluris charges approximately \$134.02 per 5,000 gallons, while Orange County Utilities charges would be approximately \$67.49 for a combined water and wastewater bill of 5,000 gallons.



Should the residents continue their efforts to acquire Pluris Wedgefield, LLC, it would require the Board of County Commissioners' approval and a Municipal Service Benefit Unit (MSBU). An MSBU would spread out the cost of the purchase over 20 years. It is estimated that affected property owners would pay an additional \$112 a month in the property tax bill to cover the cost of the purchase. With OCU's monthly pricing of \$67.49 per 5,000 gallons and the \$112 assessment, it is estimated that property owners will pay \$179.49 a month for the acquisition and Orange County Utilities services.
